Smith, 258 Pa.Super. 124, 392 A.2d 809 (1978). *844 Generally, a minor daughter cannot be a beneficiary under her mother's will, since she is not entitled to take from the mother because she cannot inherit from the mother under the laws of intestate succession. However, this is not the case in Pennsylvania. If a will includes a residuary clause, then the words "children and issue" are construed to mean "issue," and only issue can take under the residuary clause. In a recent case, Estate of Reilly, 338 Pa.Super. 323, 487 A.2d 900 (1985), this Court was faced with a will similar to the one in the case at bar. In Reilly, the testatrix named her only daughter, Caroline L. Reilly, as a beneficiary, along with the Executrix of her estate. The Executrix then set up a trust for Caroline, and another trust, the trust at issue in this case, for a son. The trust was valid and was in operation at the time of the testatrix's death. The son was an only child, and he left no lineal descendants. He died without leaving a will, and under Pennsylvania law, the son's estate escheats to the Commonwealth. The son died after the testatrix's death, but before the trust had been fully funded, and Caroline Reilly's share of her mother's estate was paid to the Commonwealth. The Reilly court pointed out that, even though the son's estate escheated, under Pennsylvania law, the daughter was entitled to receive a share of the testatrix's estate. The court reasoned that the terms of the will (including the residuary clause) and the trust established a situation where the son had no legal heir. The court pointed out that when the son died, his estate escheated to the Commonwealth, and "daughter (Caroline) was entitled to receive Caroline's share of her mother's estate, \$50,000, under the terms of the will, the trust, and under the laws of intestate succession." Estate of Reilly, 338 Pa.Super. at 328, 487 A.2d at 902. The trust at issue in the case at bar is, however, slightly different from the trust in Reilly. Carol B. Cavanaugh was the primary and residual beneficiary under the trust, and her brother was the sole income beneficiary. Both
